ARCHway Institute

Education

Peer Support

What is NPRA?

NPRA is a division of ARCHway, consisting of Certified Peer Workers from across the country dedicated to building and sustaining a more unified, empowered peer workforce to support individuals with substance use disorders.

What are NPRA's long-term objectives?

- > Ensure a sustainable peer workforce is developed.
- Ensure that peers are well-developed, properly supervised, and resource-ready. Ensure they are set up for a life-long, successful career.
- ➤ Ensure that peers are recognized as an integral part of the treatment team.
- Ensure representation of peer interests when it comes to policy and budget decisions.
- Ensure that those peers are serving receive access to the highest quality care in treatment and recovery services.

What does NPRA do to achieve its objectives?

- ➤ Develop NPRA state affiliates across the country.
- > Recruit peers for the workforce.
- ➤ Share best practices in peer work via conferences, one-on-one conversations, etc.
- Elevate the peer workforce through connecting them to educational opportunities and providing a network of support for them to share resources and best practices.
- Empower the peer workforce through providing leadership and advocacy trainings.
- Advocating for recovery support services.

Identify needs and barriers (housing, treatment, RCO's, peer workforce)




Identify policy and funding opportunities

Advocacy Efforts

Advocate on behalf of the workforce and on a state and National level around public policy.

What is the current status of NPRA?

- Four (4) active NPRA affiliates in MO, OH, WV, FL.
- ➤ Representation from 17 states
- ➤ Has an active advisory board that is fully supported by the ARCHway Institute
- ➤ Has participated in numerous advocacy campaigns (Medicaid expansion, opioid settlement dollars, etc.)
- ➤ Will be speaking at 4+ conferences in 2022 as a division of ARCHway Institute.

The Numbers are Staggering

"Provisional data from CDC's National Center for Health Statistics indicate that there were an estimated 100,306 drug overdose deaths in the United States during 12-month period ending in April 2021, an increase of 28.5% from the 78,056 deaths during the same period the year before," (CDC).

How do we change this?

We need to connect people to ALL the treatment and recovery resources necessary for recovery.

AND peers are the ones for the job!

Peers as Connectors



The Role of Peer Support Specialists

SAMHSA defines peer support specialists as people who have been successful in the recovery process who help others experiencing similar situations.

Through shared understanding, respect, and mutual empowerment, peer support specialists help people become and stay engaged in the recovery process and reduce the likelihood of relapse.

Peer support can effectively extend the reach of treatment beyond the clinical setting into the everyday environment of those seeking a successful, sustained recovery process (SAMHSA).

Peers meet those they are serving where they are and walk with them on their journey to recovery.







Recovery planning goes beyond a treatment plan, helping individuals increase recovery capital, which is defined as the internal and external factors that aid someone in finding and sustaining their recovery.



CONNECTION TO RESOURCES

Peers provide a level of care coordination, connecting individuals to treatment, support groups, resources like food stamps, Medicaid, employment opportunities, and more.



MENTORSHIP

Peers can meet one-on-one with individuals or in group settings. Peers model recovery in a way that makes it appealing while providing mentorship, which includes both personal and professional growth opportunities.



ADVOCACY

Peers provide patient advocacy, ensuring those they are serving have access to the proper care and support necessary for recovery. In addition, peers are consulted when it comes to policy and budget decisions.

The Value of Peer Services

"44% decrease in patients hospitalized and a 9% decrease in patients with an ED visit...66% increase in outpatient utilization across primary care, community health center visits, mental health, and laboratory visits."

"Study participants reported high levels of satisfaction with the online [Peer Support Solutions' video-based Depression Recovery] groups. They also reported large reduction in participants use of urgent care (-48%), emergency rooms (-50%) and hospitalizations (-69%). They also show large reduction in symptoms indicated by 33% fewer of respondents reporting that they were moderately to severely depressed."


